AND SAYS CUSS WORDS WHEN PASSES BY ME.

ME AND MY HUSBAND HAVE BEEN TO THE GYM TO TALK TO MANAGEMENT MANY TIMES, INCLUDING OLD MANAGEMENT. EVERY TIME MR KEVIN GOT A "WORD" OF ANY OF MY COMPLAINTS, HE RETALIATED EVEN MORE. THIS HAS BEEN GOING ON FOR ABOUT A YEAR, EVEN THOUGH TO ME IT FEELS LIKE MUCH MORE, BECAUSE I HAVE BEEN DEPRESSED AND UNABLE TO FUNCTION AND AVOID GOING TO THE GYM THAT I HAVE BEEN ONE OF THE FOUNDING MEMBER ABOUT 5 YEARS AGO.

HE IS A MEMBER OF THE GYM FOR SOME REASON OTHER THAN WORKING OUT, HE DOES NOT EXERCISE. HE USES THE FACILITY AS A VEHICLE TO HARASS AND STALK ME. HE WILL FIND A FRIEND OR ANY REASON TO HUNG OUT AROUND THE MACHINES I AM. MANY TIMES I'VE HAD ENDURED HIS UNPLEASANT PRESENCE FOR OVER 30 MINUTES BY MY CARDIO MACHINE I AM USING. I JUST TRIED TO PUT MY MUSIC REALLY LOUD AND TRY TO NOT TO LISTEN TO HIS NASTY, MEAN AND DIRTY CONVERSATIONS WITH A FRIEND HE HAS IN THERE.

HIS UNRULY BEHAVIOUR IS FAMOUS AT THE GYM, BUT PEOPLE ARE AFRAID OF COMING FORWARD. THEY FEEL BULLIED, JUST AS I DO. BUT HE IS OBSESSED WITH ME, AND I FEAR FOR MY SAFETY SINCE PEOPLE HAVE TOLD ME BEFORE THAT HE TALKS ABOUT ME ALL DAY WITH HIS BUDDIES OR ANYONE THAT WOULD LISTEN TO HIM. JUST WRITING ABOUT IT MAKES MY STOMACH HURT.

Respondent ME AND MY HUSBAND HAVE HIRED A LAWYER TO TRY TO GET GOLD'S GYM TO CANCEL HIS MEMBERSHIP. I AM A MARRIED WOMAN AND I AM KNOWN FOR MY GOOD CONDUCT AT THE GYM, AND THE MANAGER CHRISTINE SWAIN HAS TOLD ME THAT SHE KNOWS THAT I GO TO THE GYM DO MY ROUTINE AND GO HOME. I AM NOT THERE FOR ANY REASONS OTHER THAN EXERCISE. WHEN MR. KEVIN IS WITHIN HIS GROUP HE ACTS OUT AND A COUPLE OF TIMES HAVE DROPPED HEAVY WEIGHTS ON THE FLOOR BY ME TO INTIMIDATE ME, DROPPING WEIGHTS IS ALSO AGAINST THE GYM RULES, BUT THEY STILL WON'T CANCEL HIM OUT. THIS HAS AFFECTED ME, IS AFFECTING MY MARRIAGE, I AM MISERABLE AND DEPRESSED AND FEEL AWFUL

I HAVE A GOOD BEHAVIOUR, NEVER BOTHERED ANYONE IN THERE, WHY I WOULD BE THE ONE LEAVING? IT IS NOT FAIR THAT THE STALKER WINS. HE HAS GENERATED CHAOS IN MY LIFE, I FEEL LIKE A JOKE WHEN I ENTER THE GYM, BECAUSE I KNOW HE IS GOING TO DO THE SAME HARASSMENT AND STALKING AND NOTHING IS GOING TO HAPPEN TO HIM. IT HAS BEEN TOO LONG FOR ME TO TOLERATE THIS. THESE LAST 3 WEEKS HAVE BEEN LIKE HELL, BECAUSE AFTER I RETURNED FROM VACATION I DECIDED TO NOT TO RETREAT AND HIDE MYSELF ON THE LADY'S GYM ANYMORE, SO HE HAS GONE FULL ON ON ME, EVERY DAY HE HARASSES ME AND FOLLOWS ME AROUND WITH HIS AWFUL LANGUAGE AND GESTURES (PLEASE HELP)
