I asked them if I could have the article because I was going to include it in the small claims lawsuit I wanted to file on her. So I included it the small claims filing. Here is where the trouble started...You see that email had her phone number and her email address on it. This is where her claims of phone, email and cyberstalking started. **Amazing...I let her know I have the article along with everyone in the courts and she claims I am doing it.**
