Actually...maybe only partially crazy because I finally figured out what she is after...Money! You see the first injunction she thought I had it...remember my friend told her I had it! Ah...but what are her motivations now. Well at some point I had approached Golds Gym...probably in August and said I think that Roberta wrote this article on yelp.com. A friend of mine made me aware of the article. In the article she puts down me...my friend Debbie...the gym management...the elderly...so on and so on. You can read it down below under articles. Well she did write it cause I approached the gym management with the letter and they told me she wrote it because she had sent them an email that pulled out exact phrases from the original article.

I asked them if I could have the article because I was going to include it in the small claims lawsuit I wanted to file on her. So I included it the small claims filing. Here is where the trouble started...You see that email had her phone number and her email address on it. This is where her claims of phone, email and cyberstalking started. Amazing...I let her know I have the article along with everyone in the courts and she claims I am doing it.

So read...Read all the lies...I went through 3 court hearings in Broward to get this one thrown out. After you read you need to read the button labeled State Atty. The Assistant State Attorney did a 3 month investigation from March till the end of May and found zero evidence. This case was heard before the State Attorney knew anything about the issues and got thrown out on jurisdiction.
