My attorney suggested we get a background search done on her and her husband. We did not do this till April 4th 2012. My parents received this report probably on the 8th. I was out of town and had been for a while working construction. They told me she had a place in Fort Lauderdale till the 22nd. They never told me the address nor did I care. After this I have no idea where they are living now. As for her husband...he should be in jail right along side her for starting the cyberstalking lies.

FOR ALMOST TWO YEARS NOW I HAVE BEEN A TARGET OF THIS MAN'S OBSESSION, STALKING, HARRASSING, FOLLOWING, SHADOWING, BULLYING, CYBERSTALKING, THREATENING, AND INTIMIDATING ATTEMPTS. HE HAS POLICE FRIENDS BACK ON LAKE COUNTY FLORIDA AND ONE OF THEM HAS THREATENED AND INTIMIDATED ME AND MY HUSBAND, BECAUSE WE WERE SPEAKING UP ABOUT "HIS FRIEND" AS HE REFERED TO MR. KEVIN. "AND THAT I WAS TAKING IT TOO FAR", REFERING TO MY POLICE COMPLAINTS AND RESTRAINING ORDER.

I HAVE MOVED BACK TO BROWARD COUNTY, WHERE I USED TO RESIDE BEFORE GETTING MARRIED, SINCE HIS POLICE FRIEND SEEMED TO BE MANIPULATING ANY AND EVERY ONE OF MY ATTEMPTS TO GET JUSTICE FOR THE CRIMES BEING COMMITTED AGAINST ME.

I FILED FOR A RESTRAINING ORDER ON OCTOBER 27TH OF 2018 IN BROWARD COUNTY, WHERE I HAVE PROOF OF BE RESIDING FOR ALMOST 7 MONTHS.

UNLIKE THE LAKE COUNTY RESTRAINING ORDER HEARING, THAT LASTED LESS THAN 10 MINUTES AND MR. KEVIN WAS ALLOWED HIS POLICE FRIEND AS HIS "WITNESS" AND I WAS DENIED / NOT ALLOWED ANY WITNESSES OR

EVEN GIVEN THE CHANCE OF HIRING COUNSEL, AS MR. KEVIN WAS GIVEN IN BROWARD, SO HE COULD HAVE A FAIR CHANCE, SINCE I HAD AN ATTORNEY. THE JUDGE ON BROWARD COUNTY WAS VERY FAIR AND ANOTHER HEARING DATE WAS SET. THAT'S WHEN MR. KEVIN AND HIS ATTORNEY HANDED TO ME AND MY ATTORNEY THIS DISTURBING "WITNESSES LIST" FROM HIS PART. I SAW THE NAME OF PLEASANT LEWIS, THE OWNER OF THE GYM THAT IN FIVE YEARS OF MEMBERSHIP, ME AND MY HUSBAND MET ONLY ONCE, SINCE HE WAS NEVER THERE AND HE VIOLATED MY RESTRAINING ORDER BY TERMINATING MY MEMBERSHIP (A LOYAL MEMBER), JUST TO KEEP THE STALKER (THAT NEVER WENT THERE TO WORKOUT) BUT ONLY USED THE GYM TO BULLY AND HARASS AND

TO DATE FEB/MARCH 2016 HE IS 45 YEARS OLD, HAS NO JOB, LIVES WITH HIS PARENTS, HAS NO WIFE OR GIRLFRIEND AS FAR AS WHAT IS KNOWN ON TOWN. I AM NOT GOING TO BE THE OUTLET OF HIS OWN FRUSTRATIONS WITH HIS LIFE, HE NEEDS TO STOP HIS QUEST TO TRY ~~DO~~ DESTROY ME AND MY FAMILY. WE HAD NORMAL AND PRODUCTIVE LIVES BEFORE WE EVEN KNEW HE EXISTED AND WE DESERVE OUR FREEDOM AND NORMALCY THAT HIS HAS WORKED ON TAKING FROM US FOR AROUND TWO YEARS NOW.

I HAVE LEFT MY HOUSE THAT ME AND MY HUSBAND OWN, BECAUSE NONE OF MY COMPLAINTS IN LAKE COUNTY WERE GOING ANYWHERE, HE HAD HIS ACQUAINTANCES AND FRIENDS ON POLICE THAT MADE SURE HE WAS GETTING AWAY WITH IT ALL IN LAKE COUNTY.

I HAD A JOURNAL OF ALL OF THE INCIDENTS AND WE HAD ATTORNEY'S WRITE LETTERS TO THE GYM DEMANDING THE SURVEILLANCE/SECURITY TAPES BE PRESERVED, BUT THEY NEVER APPEARED ON ANY INVESTIGATION. THE ASSISTANT STATE ATTORNEY IN THERE HAS TOLD ME IN PERSON THAT THE FOOTAGE WAS NEVER INVESTIGATED.

TO ADD TO ALL OF THE DISTURBING SITUATION SOME POLICE OFFICERS PREVENTED (BY DIFFERENT WAYS) THAT HE BE ACCOUNTABLE FOR HIS ACTIONS
