Now we are on injunction 3. Pretty much the same ramblings as before, but now she claims I am posting pornographic photos of her, stalking her at her new place of residence, and now I am cyberstalking her husband. First off...where am I supposed to get pornographic pictures of her? Stalking her at her new apartment...Well I did not know where she lived. My attorney suggested we get a background search done on her and her husband. We did not do this till April 4th 2012. My parents received this report probably on the 8th. I was out of town and had been for a while working construction. They told me she had a place in Fort Lauderdale till the 22nd. They never told me the address nor did I care. After this I have no idea where they are living now. As for her husband...he should be in jail right along side her for starting the cyberstalking lies.


